New to the Library

We have some new entries in the NWT Lending Library, the home school of woodturning. The videos should be available to you at the December meeting if our librarian is able to attend and get them properly logged in. We will also have a few books that will be available at the January meeting. Reviews of the books will appear in the January newsletter.

First new videos are not new at all, and really not even new to us. We've had a couple of variations on them in our library since the beginning. The one tape remaining in this series needs to be retired as it is old and tired and now remastered to DVD.

The name Bonnie Klein is not a new one to our members. Her first three videos are seen by some as classics. Again, these are not new videos. They are, however, still some good, basic instruction on turning of wood and other materials. We continue to expand and renew our library with materials that will appeal to novice, intermediate and advance turners.

The three videos by Bonnie are:

- Volume 1, Techniques & Projects
- Volume 2, Bowls & Other Projects
- Volume 3, Boxes & Other Projects

In these videos, she gives basic instruction on sharpening, basic tool techniques, and essential lathe skills such as mounting materials and finishing. When I first started turning, I spent a *lot* of time watching and studying these three videos. They provided some simple projects that were extremely accomplishable, even by novice turners. Bonnie's whole teaching ethic is to make turning available and fun for anyone. She does just that in these videos. I've recommended these for years to folks asking, "Where do I start?" Watch Volume 1! Then watch it again and take notes. Then watch the first part about basic skills and go to the shop and *do* it. Bring in your project and rewind a bit; compare it to what she showed you. If it's a pretty good match, go to the next exercise. If not, rewind and go back to the lathe! She is not "playing to the audience" in these videos and at times comes across as being a little uncomfortable in front of the camera, very different than she is in person, but again, the materials are great for

beginners. She teaches her ever-present tops, lidded boxes, earrings, spheres, thimbles, a mini-goblet, tool handles, and various chatter-work. Video 1 is 2 hours, #2 & 3 are 105 minutes each. Worth watching and reviewing in this reviewer's opinion.

The second new entry to the NWT library is a dandy series of three tapes by a relative newcomer to the US turning scene, Jimmy Clewes. Jimmy seems so very comfortable in front of the camera. Watching these, you'll want to raise your hand and ask questions. He is that present in these excellent quality videos. If I could nominate the videographers on this series for awards, I'd do it in a Kansas City minute! In my opinion, the technical quality on these videos will become the standard by which you'll judge all other videos, that's how good they are. Quoting Jimmy's own site, "he explains everything he does and the camera work captures every detail in stunning close-ups and crane shots from Jimmy's point of view." They're right.

Each of the three videos in this set are two hours in length, chock full of great footage. Disc 1 projects include a footless bowl made of spalted birch burl and an oriental-style box with 22 carat gold leaf inlay. Also includes valuable information on flutes, bevels, and tool sharpening. Bonus footage gives a behind-the-scenes look at the life of a professional woodturner. Disc 2 projects include a zircote bowl with a brass rim inlay and a long stem goblet (turned unsupported) from Australian myrtle. Jimmy also takes you through the process of breaking down a tree into useable turning stock including instructions on cutting for figure, maximum yield, and proper handling of unseasoned wood. Disc 3 projects include a lidded box made of laminated maple and wenge and a footless bowl with silver highlights made from walnut burl. Jimmy also uses easy-to-follow diagrams to explain tried and tested methods used for fitting a box lid. Bonus footage takes a behind-the-scenes look at the making of the Turn It On DVD series.

Jimmy also has a brand new series of 3 videos that I hope we can also add to the library. Check these out and tell Dr. Frank what you think! Let us know if you'd like to see more of Jimmy.
